Soulstice in the Park is an outdoor event that showcases a vast array of healing and metaphysical vendors, while also highlighting local artists, crafters, and creatives. Its purpose is for attendees and vendors to connect with like hearted individuals, to enjoy local art, and to experience healing for the body, mind, soul, and spirit!

All booth spaces are 10' x 10' unless otherwise arranged. Table/chairs are NOT provided for this event. This is an outdoor event, under a large covered pavilion space and also featuring space on the lawn surrounding. Vendors must provide their own tables/chairs/pavilion coverings. Limited electrical hookups *may* be available, based on park maintenance, but cannot be guaranteed. If electricity is not available for your booth, this amount will be refunded to you.

We do our best to accommodate vendor special requests, such as booth placements and electrical hookups, but your requests **MUST** be submitted along with your application at least one month prior to the expo. Requested accommodations are not guaranteed unless otherwise stated.

Online payment options include paypal or venmo. You will receive an email letting you know when your request has been received. Please note that fees are non-refundable unless otherwise noted in our terms and conditions, as they are used to secure the space, advertise the event, etc.

Show Rules:

- **Booth Content:** All booths must maintain legal and appropriate content suitable for all ages.
- **Permits & Compliance:** Vendors are responsible for obtaining proper sales and use tax permits, business licenses, and ensuring compliance with all local and state regulations.
- **Sage Burning:** Small quantities of sage may be burned before the event opens to the public. Once the event starts, only smokeless sage may be used to accommodate potential allergies.
- **Booth Usage:** Booths are designated for the person or business submitting the application. Subleasing is not permitted. Booth sharing is allowed at no additional fee, but all parties must be listed on the application.
- **Event Duration:** Vendors are required to stay for the entire event unless prior arrangements have been made. Early departure disrupts the experience for attendees. Event hours are Noon to 6:00 PM.
- **Setup & Teardown:** Vendors may setup starting at 7:00 AM on the day of the event. All booths must be dismantled, and the area cleared by 9:00 PM on the same day.
- **Parking:** Vendors may use the gravel side parkinglot for unloading but must move their vehicles to the street or Aquacourt parking immediately after unloading.

Vendors are responsible for providing their own tables, chairs, and tablecloths. **A very limited amount of electrical outlets are available for an additional \$20 and must be requested at the time of application.** All requests must be received by May 31, 2026.
