Vendor setup is available the day before the show, September 25th, from 5-8PM. Vendors who choose day-before setup must sign a waiver and understand that our venue does not provide additional security, and that they are responsible for any risks involved.

**All booth spaces include ONE 8' table and two chairs, with additional tables/chairs available by request. Electricity is available on a by-request basis, in limited supply.**

We do our best to accommodate vendor special requests, such as booth placements and electrical hookups, but your requests MUST be submitted along with your application at least one month prior to the expo. Requested accommodations are not guaranteed unless otherwise stated.

#### **Show Rules:**

**Booth Content:** All booths must maintain legal and appropriate content suitable for all ages.

**Permits & Compliance:** Vendors are responsible for obtaining proper sales and use tax permits, business licenses, and ensuring compliance with all local and state regulations.

**Sage Burning:** Small quantities of sage may be burned before the event opens to the public. Once the event starts, only smokeless sage may be used to accommodate potential allergies.

**Booth Usage:** Booths are designated for the person or business submitting the application. Subleasing is not permitted. Booth sharing is allowed at no additional fee, but all parties must be listed on the application.

**Event Duration:** Vendors are required to stay for the entire event unless prior arrangements have been made. Early departure disrupts the experience for attendees. Event hours are 10:00 AM to 5:00 PM.

**Setup & Teardown:** Vendors can set up starting at 7:00 AM on the day of the event. All booths must be dismantled, and the area cleared by 9:00 PM on the same day.

**Parking:** Vendors may use the front area for unloading but must move their vehicles to the south parking lot afterward to reserve closer spaces for attendees.
